Executive Board Meeting Minutes
March 25, 2007

The Executive Board meeting of the Lower Bucks Swim League was called to order by League President Jack Cataldi at 7:10 p.m.

1. Roll Call

Executive board members in attendance were Jack Cataldi, Stan Salwach, Linda Rios, Tim Schenkel, Coleen Long and Kathy Gillespie. Pat Ryan and Sally Lewing were not in attendance.

2. Minutes

The minutes from the September 11, 2006 meeting were reviewed and accepted by the executive board members in attendance.

3. Reports

A.) President

Jack Cataldi welcomed the executive board to the 2007 swim season and thanked Linda Rios for her hospitality in hosting the executive board meeting in her home.

The first league meeting of the 2007 season will be held on Tuesday, April 10, 2007 since Monday, April 9, 2007 is Easter Monday and many people have plans for vacations over the Easter holiday. The league meeting schedule is as follows:

B.) Vice President

Stan Salwach will order 3 trophies and 3 plaques for the 2007 Champs. Stan will also place the Champs t-shirt order.

C.) Treasurer

Linda Rios has placed the badge order. Linda does not have any bank statements yet, but on 03/15/2007 she determined that the league bank balance was \$9,539.81 and one check in the amount of \$4,506.12 was written for the badge order.

Linda will order the U.S. Swimming Rules Books for distribution to teams and has the Officials' shirts for distribution at Officials' clinics.

D.) Operating Secretary

Sally Lewing wants to remind all teams that one table worker from each swim club MUST attend a table workers clinic this season.

E.) Diving Vice President

Tim Schenkel and Coleen Long asked what the procedure was to determine a winner in a tie situation. After discussion among the board members, it was determined that they should count diving head to head, then total points for all divisions. If there is still a tie after that math is done, USS six place scoring is used.

Tim would also like to hold a clinic for diving officials, just as the swim teams have officials' clinics. He would like to have one diving official from each team attend the training. He also asked permission from the Board to purchase diving DVDs to use as an instructional tool at the clinic. Permission was granted, and Tim hopes to make one copy of the DVD available for distribution to each of the swim clubs with diving teams.

F.) Diving Secretary

Coleen Long advised that Torresdale will host diving champs. Coleen is gathering information concerning fees, etc. and will provide them to the league as soon as possible. Coleen will order the Bub Mears award plaque for diving.

4. New Business

Motion from the diving Vice President and Secretary (change to diving operating procedures concerning resolution of a tie situation) will be addressed at the April 10, 2007 league meeting. Committees for 2007 Champs will be formed. A vote will be taken regarding which pool will be used to host Champs (Central Bucks South or College of New Jersey).
